## **Application Guidelines**

Call for Proposals for the "Project of future business opportunities for ASEAN and Japan's next generation for enhancing the industries during the Philippines's ASEAN Chairmanship" Using AMEICC's FY2022 Supplementary Budget

## 1. Project Purpose and Objectives

Addressing critical challenges by the rapid economic development that ASEAN countries are facing, especially in the areas of strengthening the competitiveness of SMEs and responding to the digital economy, sustainable development, innovation, green technology and climate action, necessitates a comprehensive and collaborative approach, especially through fair and mutually beneficial economic co-creation between ASEAN and Japan. Tackling these challenges demands the establishment of a shared future wherein various players such as the youth can play a pivotal role as drivers of innovation and sustainable economic growth. Therefore, it is of importance to create a dialogue where these players could exhibit a heightened interest in ASEAN through activities that empower them and engage communities to instill and implement ideas that enable positive sustainable change. Such a dialogue will lead to sustainable and resilient supply chains between ASEAN and Japan that enable various players to participate. Given the Philippines's role as the upcoming ASEAN Chairmanship, exploring future business opportunities between ASEAN and Japan in areas that align with their priorities contributes significantly to realizing a more resilient, inclusive and sustainable future for the region.

This project will (i) provide opportunities for various players such as young leaders of ASEAN and Japan to directly engage, collaborate and jointly work towards strengthening close ties between the two regions to promote diverse inclusion in areas such as strengthening the competitiveness of Small and Medium-sized Enterprises (SMEs) and responding to the digital economy, (ii) raise awareness and understanding of current trend of ASEAN's policy including SMEs development and digital strategy, and methodologies for addressing the persistent vulnerabilities of SMEs to develop a long term and effective mechanisms, (iii) facilitate networking and collaboration among stakeholders and key players in concerned industries for best practices, perspectives, initiatives and practical approaches, (iv) encourage knowledge sharing and community engagement to tackle the poor managerial capabilities, limited access to the finance and market, the digital skill gaps as well as the climate crisis through learning and mentoring from successful strategic businesses focused on digital innovation and developmental partners organizations and (v) explore and implement innovative strategies for building resilient economy and sustainable development as well as offer policy recommendations to the high-level stakeholders in ASEAN.

#### 2. Service to be commissioned

The contractor selected through this call for proposals shall be commissioned by the Association for Overseas Technical Cooperation and Sustainable Partnerships (AOTS)<sup>1</sup> to implement the following services (1) through (3). Detailed contents and methods of implementation shall be based on proposals, and the project shall be implemented after careful consultation with the AMEICC Secretariat and the Ministry of Economy, Trade and Industry, Japan (METI)<sup>2</sup>.

(1) Organizing the public forum focusing on strengthening the competitiveness of SMEs and responding to the digital economy to achieve sustainable development at multiple levels (e.g. firm, supply chain, nation and region) in 2026.

This service will focus on raising participants' awareness and understanding of the importance of SMEs in the region, digital innovation, and sustainable development as well as ways to contribute to solving SMEs' challenges and achieving inclusive economic growth. Key priorities include supporting SMEs and bridging the digital divide, along with other composition such as a panel discussion engaging diverse representatives from the government, private sectors, and international development organizations in the ASEAN region. Possible initiatives, ideas and viewpoints from different key players could be recognized on this occasion in the following fields:

- (a) Current initiative to strengthen SMEs and digital economy through the collaboration of ASEAN and Japan,
- (b) Innovative financing models and partnerships between the governments and SMEs to support accessing finance and markets, enhancing managerial capabilities and digital skills, utilizing innovative technologies, and building resilient businesses capable of withstanding climate change and economic shocks,
- (c) Strengthening the competitiveness of SMEs and its methodologies,
- (d) Local development and establishment of socio-business to build a resilient economy
- (e) Technology and innovation, and
- (f) Other matters to solve socio-economic issues.

The specifications for this service shall be as follows:

- (a) Period of implementation: The event is anticipated to span approximately three days,
- (b) Location: The event will be held in Philippines,
- (c) Method: The event format will be predominantly offline (face-to-face) with potential for a hybrid model incorporating online elements,

- (d) Expected number of participants: A minimum of 200 participants (face-to-face) are envisaged for the public event,
- (e) Targeted participants: The event aims to engage youth (encompassing young professionals, entrepreneurs, SMEs, start-ups) and representatives from various ministries, private sectors, and academia in ASEAN and Japan,
- (f) Hosting arrangements: The event may be co-hosted with multiple organizations,
- (g) Organizing learning visit on SMEs initiatives and sustainable economic growth: This site visit will be conducted to expand engagement and understanding of the various mechanisms and opportunities on empowering SMEs initiatives and its sustainable growth, allowing participants to interact and acquire insights and technology which are the clues to build a resilient economy and to bring innovation, and
- (h) Implementation of human resource exchanges: To include a multinational human resource exchange of young people from Japan and ASEAN countries in order to deepen multicultural and intercultural understanding and explore the possibility of sustainable co-creation in the SMEs issues and economic issues.

## (2) Side Event: ASEAN-Japan Collaborative Fieldwork by Youth

As a side event of the public forum mentioned (1), a collaborative fieldwork program involving youth from Japan and ASEAN will be organized with the following conditions:

- (a) Objective: To co-create solutions for common social challenges in ASEAN and Japan (e.g., SME support, digital divide, regional sustainability).
- (b) Participants: A minimum of 15 youth participants each from ASEAN and Japan.
- (c) Location & times: In principle, to be conducted either in Japan or an ASEAN country for more than 3 times (however, partial implementation outside Japan and ASEAN is allowed if highly effective.)
- (d) Duration: Minimum of three days per 1 fieldwork, including activities such as issue analysis, site visits, idea creation, and presentation.

### (3) Promoting public relation activities

This service aims to promote and publicize above (1) and (2) through broadcasting on various social network platforms including Facebook, Instagram, Twitter, and others.

#### 3. Points of Concern

- (1) In implementing the project, the contractor should cooperate well with the AMEICC Secretariat and Asia Pacific Division of METI.
- (2) The progress of the project shall be reported in principle once every two weeks, as appropriate, in

response to instructions from the AMEICC Secretariat and Asia Pacific Division of METI.

Data shall be submitted in accordance with the data delivery methods and addresses specified by (A) and (B), respectively. In addition, printed materials shall also be delivered upon request as appropriate.

## 5. Contract Requirements

- (1) Contract form: Quasi-mandate contract
- (2) Contract method: Fixed Payment Contract
- (3) Number of contracts: one
- (4) Contract period: From the date of the contract (scheduled for Mid-September 2025) to March 31, 2026.
- (5) Contract amount: The maximum contract amount shall be 110,000 USD. The final implementation details and contract amount shall be determined after confirming and adjusting the adopted proposal. The contractor shall not subcontract (outsource, or any other form of entrustment, regardless of the form of entrustment. Hereinafter referred to as "subcontracting".) to a third party more than 50% of the actual amount of the consignment fee (including consumption tax). The administrative expenses shall be calculated by multiplying the direct expenses excluding the subcontracting expenses by the administrative expense ratio, with the maximum administrative expense ratio being 10%.
- (6) Client: AOTS

(7) Payment: The contract amount will be paid after acceptance of the deliverables specified in 4. (1) submitted at the end of the project. However, advance payment of up to half of the amount is allowed. However, if the contractor fails to perform the services specified in the TERMS OF REFERENCE (TOR), the AOTS may withhold all or part of the payment.

# 6. Application Requirements

- (1) The applicant must be registered as a legal entity in ASEAN.
- (2) The applicant must not fall under any of the following:
  - · A legal entity that does not have the capacity to conclude a business service contract for the Project,
  - A legal entity that has received a decision of commencement of bankruptcy proceedings and has not been reinstated,
  - · A juridical entity of which a designated organized crime group<sup>3</sup> member is an officer,
  - A juridical entity that a designated organized crime group member has a controlling influence over its business activities through investment, financing, transactions or other relationships,
  - A juridical entity that is barred from participating in competitive bidding by Japanese public offices.
- (3) The applicant must not have been subject to suspension of subsidies or suspension of nomination due to fraudulent or inappropriate acts in the subsidization projects under the jurisdiction of the Ministry of Economy, Trade and Industry of Japan.
- (4) The applicant shall have the organization, system, and personnel, etc. sufficient to properly perform the services.
- (5) The applicant must have the necessary management infrastructure to smoothly carry out this operation and sufficient management capabilities with respect to funds and other matters.
- (6) The applicant must not be one for which a petition for commencement of corporate reorganization proceedings or rehabilitation proceedings has been filed in the country of incorporation. (Excluding a legal entity that has been recertified after the decision of commencement of proceedings).

10. Screening Method

answered.
