2021 AOTS Webinar [KROP11] For continuous 5S and Kaizen that you can successively develop

---Challenge to Kaizen Marathon---

BACKGROUND

The Association for Overseas Technical Cooperation and Sustainable Partnerships (AOTS) is an organization for human resources development mainly in overseas countries to promote technical cooperation through training, experts dispatch and other programs. Through those programs, we aim at contributing to the mutual economic growth of developing countries and Japan as well as enhancing friendly relations among those countries.

AOTS webinar "How to implement 5S and Kaizen that can be continued ---Challenge to Kaizen Marathon---", is a program suitable for improvement activity team leaders or managers who are engaged in improvement activities or have plans for future efforts to learn how to proceed with improvement activities and how to carry them out continuously.

OUTLINE

The economic shock caused by the global epidemic of the new coronavirus infection is still significant, and developing countries need to improve the productivity of their companies in order to survive the headwinds of the coronavirus.

Regarding improvement activities, which are effective means for improving the productivity of companies, some companies do not understand the specific points of improvement activities and how to start them, or introduce them. There are also, many companies that improvement activities stay only temporary and do not take root in the corporate culture or companies that do not understand the necessity of continuation.

This program is designed for managers who want to gain the approval and understanding of the top of the companies in the development of improvement activities, and team leaders who motivate team members and promote activities to acquire the knowledge and know-how necessary for improvement activities and creating a corporate culture while focusing on 5S (especially Sitsuke, discipline), the basis of kaizen activities and removing Muda (waste).

OBJECTIVES

We aim for improvement activity team leaders or managers who are engaged in improvement activities or have plans for future efforts in companies in developing countries to achieve the following goals:

- 1) To understand the three steps of improvement activities.
- 2) To understand the basics of 5S activities, specific efforts and points of implementation as a foundation for company-wide improvement activities.
- 3) To understand specific efforts and application examples of improvement activities such as removing Muda (waste) and loss detection.
- 4) To understand how to continuously carry out and establish improvement activities.

- a) Participants should live and work in target countries. Japanese is NOT applicable.
- b) Participants should belong to either corporation or organization.
- c) Participants should be 20 years old and over.
- d) Participants should have enough English language ability so as to be able to understand the program content.
- e) Participants should not be armed forces personnel.

Notes:

- 1) In the case of applications from other than Japanese-affiliated companies or local companies that hold local capital, the priority for selection becomes lower.
- 2) This training is mainly aimed at the people working in the companies/organizations in the private sector, so those who belong to national or local government agencies are not eligible to participate.
