2022 AOTS online program [KROP11] Online Program on Amoeba Management

BACKGROUND

The Association for Overseas Technical Cooperation and Sustainable Partnerships (AOTS) is an organization for human resources development mainly in overseas countries to promote technical cooperation through training, experts dispatch and other programs. Through those programs, we aim at contributing to the mutual economic growth of developing countries and Japan as well as enhancing friendly relations among those countries.

The Online Program on Amoeba Management (KROP11) is an online program designed for company owners, executives, senior and middle managers in developing countries. The program is suitable for participants who wish to learn about amoeba management (a method where all employees work together to improve management).

OUTLINE

With the effects of the COVID19 still continuing, the business environment remains difficult to predict. Amoeba Management is one management method that can help companies overcome and transform in such a crisis.

Amoeba Management is a business management method developed by Kazuo Inamori, Chairman Emeritus of KYOCERA Corporation, based on his own experience in company management, and is characterized by the sharing of a management philosophy between management and employees, and the participation of all employees, rather than company management being carried out by only some senior management.

In this program, company owners, executives, senior and middle managers in developing countries will deepen their understanding of the concepts that form the basis of Amoeba Management, such as the penetration of a management philosophy that elicits commitment from employees and a field-oriented approach from management. Participants will also learn specific examples of management methods that enable all employees to share the philosophy and work towards cost reduction and sales expansion with a managerial awareness, with the aim of enabling them to apply the concepts and methods of Amoeba Management in their own companies, sustain management in times of crisis and utilize them for management improvement.

OBJECTIVES

This online course aims to company owners, executives, senior and middle managers in developing countries to achieve the following goals:

- To deepen understanding of each of the characteristic elements that make up the concept of Amoeba Management and the management philosophy that underpins the foundations of Amoeba Management through lectures and discussions.
- 2) To deepen understanding of the structural features of amoeba management by considering whether each department of the enterprise is a Profit Center or Cost Center, and if a Profit Center, how income is defined.

- 3) To deepen understanding of the mechanism of Hourly Efficiency Report and the PDCA cycle through lectures and exercises.
- 4) To share what they have learned from this program, what they thought they could implement in their own country/company and what they thought would be difficult to implement, to improve their own management after program through group discussions and presentations by group representatives.

In order to participate in this program, the following conditions must be satisfied, in addition to the work experience and position requirements specified for each program.

- a) Participants should live and work in target countries. Japanese is NOT applicable.
- b) Participants should belong to either a corporation or an organization.
- c) Participants should be 20 years old and over.
- d) Participants should have an advanced Spanish language ability sufficient to be able to actively discuss with the lecturer and fellow participants.
- e) Participants should have an basic English language ability sufficient to be able to read and comprehend the materials since the lecture materials will be prepared in English.
- f) Participants should not be armed forces personnel.
- g) Participants should not be students.

Notes:

- 1) Applicants from the consulting industry will be given lower priority in the selection process. However, participation may be possible with conditions. Please contact the address in the inquiry if you wish to participate.
- 2) Applicants from a company with capital from a developed country other than Japan, you will receive lower priority during the selection process.
